WHEREAS, a petition has been presented to this Board seeking the creation of a Housing Authority in Collier County pursuant to the provisions of Chapter 421, et. seq., Florida Statues, and

AUTHORITY PURSUANT TO CHAPTER 421, FLORIDA STATUES

WHEREAS, said petition has been referred to the Supervisor of Registration of Collier County and has been found to contain the signatures of at least twenty five (25) persons who are residents and freeholders of said County, and

WHEREAS, upon consideration it has been found that there is need for the creation of said Housing Authority and for said Housing Authority to function in Collier County in view of the fact that insanitary and unsafe inhabited dwelling accommodations exist in said county and that there is a shortage of safe and sanitary dwelling accommodations in said county available to persons of low income at rentals they can afford, and

WHEREAS, the Board of County Commissioners of Collier County in reaching this determination has taken into consideration the degree of evercrowding, the percentage of land

average, the light, air, space and access available to the inhabitants of the aforesald dwelling accommodations, the size and arrangement of the rooms, the sanitary facilities, and the extent to which conditions exist in such buildings which endanger life or property by fire or other causes.

NOW, THEREFORE, BE IT RESOLVED that a Housing Authority pursuant to Chapter 421, Florida Statues, be and the same hereby is created, activated, authorized to function and transact its business and exercise its powers pursuant to said Statue made and provided, and to be known as the Collier County Housing Authority.
